Applications for Leave of Absence

After each five years of service in the district, a teacher may apply to the Leave of Absence Committee for full-time Personal Leave **for whatever reason they wish.** Full-time Personal Leave will be granted for a period of not more than one year.

A full-time teacher who, **prior to March 15**, requests to teach part-time commencing the following school year, shall be granted their request provided the assignment is "compatible with the organization of the Board." A teacher may request an extension of their part-time assignment for up to three consecutive years.

On recommendation of the Leave of Absence Committee, the Board will grant teachers Educational Leave with no salary for a specified period. The date of return to duty will be clearly stated when the leave is granted. *Please call the WVTA office if you need further clarification or some advice.*

BCTF Teachers' Council Elections

The BC Teachers' Council (BCTC) elections will be held in March 2024. Voting opens on March 6, 2024, and closes on March 20, 2024, at 4:30 PST, and voting is open to all certificate holders. The BCTC will send instructions by email, and the voting platform will be online only. Candidate profiles and information can be found on the <u>elections page</u>. To ensure you can participate in the election, as soon as possible:

- Ensure your contact information, especially your email address, is up to date in <u>Your</u> <u>Account</u>, which is accessed using your BCeID login.
- If you need help logging in to Your Account or linking your BCeID, or with your certificate number, please call Services BC at one of the following numbers: Vancouver at 604-660-2355 or toll-free at 1-888-356-2741. There is also a helpful BCeID FAQ <u>here</u>.
- 3. Ensure that your inbox isn't full so that you can receive election emails.

An email went out to certificate holders on Feb. 22, so please check your email, including your junk folder.

Know the election zone in which you reside:

The election zones correspond with the five <u>regional</u> <u>health authorities</u>, and certificate holders can **only** vote in the **zone where they live**.

One election takes place in each election zone:

- Fraser Zone
- Interior Zone
- Northern Zone
- *Vancouver Coastal Zone
- Vancouver Island Zone.


Know your candidates. Successful candidates will be elected for a three-year term beginning in April 2024.

There are <u>18 members</u> on the BC Teachers' Council (BCTC):

- Five members are elected by teachers
- Four members are appointed by the minister based on nominations from the BCTF
- Seven members are appointed by the minister from other education partner groups' nominations
- One member is appointed by the First Nations Education Authority
- One non-voting member is appointed to represent the minister

*Of note, WVTA member **Emily Lacock** (PJ) is a candidate in the Vancouver Coastal Zone.

BCTF Statement on Cell Phones in Schools

The BC Teachers' Federation has not received direction from its membership to take a position on whether cell phones in classrooms should be banned provincially. The Federation strongly supports the professional autonomy and rights that members have to do their important work as educators. Teachers, schools, and school districts have a variety of ways to address cell phone use in classrooms and schools, which may involve some or no restrictions.

Cell phones can have both positive and negative impacts on classroom learning. They can be a

distraction, and they can also serve as a helpful resource to support learning if there is equitable access to technology.

Writing a province-wide policy that would be appropriate for everyone everywhere would be a difficult task. However, should the government work on such a policy, it's important to include teachers' voices at the table to ensure that on-the-ground classroom needs and expectations are considered.

All that said, there are much larger issues facing public education than cell phone use. Teachers need adequate resources to ensure no child goes without the support they need. If BC United is sincere in wishing to improve learning conditions, the Federation looks forward to hearing their plan for recruitment and retention strategies to solve the acute staffing shortages in schools.

Although only delegates and LRs can vote at the AGM, any teacher is welcome to attend, although seating is limited. Come and look for your WVTA delegates at their assigned table.


"Understanding your Benefits and Pension Income in Retirement" CPP, OAS and Group Benefits: An Essential Workshop from BCRTF
